Freedom of Information Request - FOI18-68

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the FOI Act), received by ACT Health on 6 September 2018, in which you sought access to:

All documents recording and/or referring to:

- The total number of person's in the ACT who identify as Aboriginal and Torres Strait Islander and are currently employed or engaged in a Healthcare occupation by ACT Health.
- 2. The total number of person's in the ACT who identify as Aboriginal and Torres Strait Islander and for each annual period between 2010 and 2018 (inclusive), were employed or engaged in a Healthcare Occupation by ACT Health.
- The number of Aboriginal and Torres Strait Islander Health Workers (ATSIHW) and Aboriginal and Torres Strait Islander Health Practitioners (ATSIHP) in the ACT who are currently employed by ACT Health and/or registered with the Aboriginal and Torres Strait Islander Health Practice Board of Australia.
- 4. The total number of ATSIHW's and ATSIHP's in the ACT for each annual reporting period between 2010 and 2018 were employed by ACT Health and/or registered with the Aboriginal and Torres Strait Islander Health Practice Board of Australia.
- 5. The total number of ATSIHW's and ATSIHP's, in the Australian Capital Territory who are currently employed by ACT Health and/or registered with AHPRA.
- The total number of ATSIHW's and ATSIHP's, in the Australian Capital Territory for each annual period between 2010 and 2018, were employed by ACT Health and/or registered with AHPRA.
- 7. The total number of ATSIHW's and ATSIHP's, in the Australian Capital Territory who are currently employed by ACT Health and/or engaged in Aboriginal and Torres Strait Islander Community Controlled Health Services.
- The total number of ATSIHW's and ATSIHP's, in the Australian Capital Territory who, for each annual period between 2010 and 2018, were employed by ACT Health.and/or engaged in Aboriginal and Torres Strait Islander Community Controlled Health Services.

- The total number of ATSIHW's and ATSIHP's who are currently employed and/or engaged by ACT Health and in rural and/or remote locations within the Australian Capital Territory.
- 10. The total number of ATSIHW's and ATSIHP's in the Australian Capital Territory who from 2010 and 2018 (inclusive) were or are currently employed by ACT Health and enrolled in various Aboriginal and Torres Strait Islander Primary Health Care vocational training and accreditation courses.

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

ACT Health was required to provide a decision on your access application by 5 October 2018.

Decision on access

In relation to information requested at points one and two of your request, I have decided to grant full access to two documents relevant to your request. I have included as Attachment A to this decision the schedule of relevant documents. The document released to you is provided at Attachment B to this letter.

In relation to the information requested at points three to six of your request, I have not provided information (as per section 45 of the Act), as the information is already publically available or contained in the documents referred to at Attachment B above. The information you requested can be accessed at:

In relation to the information requested at points seven to ten of your request, a search of ACT Health records has failed to identify any documentation in relation to these items in your request. The search was conducted using the information you provided. I am satisfied that appropriate searches were completed and that no documents relevant to these items are held by ACT Health.

Charges

Processing charges are not applicable to this request because the total number of documents released is less than 50 pages.

Online publishing – disclosure log

Under section 28 of the Act, ACT Health maintains an online record of access applications called a disclosure log. Your access application, my decision and documents released to you in response to your access application will be published in the ACT Health disclosure log not less than three days but not more than 10 days after the date of this this decision. Your personal contact details will not be published.

Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in ACT Health's disclosure log, or a longer period allowed by the Ombudsman.
