

Thank you Chief Minister.

It's great to be here in Canberra's south and to be announcing the expansion of local health services for the more than 85,000 people who live in this beautiful part of the ACT.

In 2016, the ACT Government made an election commitment to introduce an initiative to support bulk billing general practices in the ACT.

So I'm pleased to be here today to deliver on that promise and announce the recipients of the first of the bulk billing grants.

Grants that will allow access to more affordable, high quality health care for people living in Tuggeranong.

We know that our general practices play an important role in keeping Canberrans healthy. That is why we have been determined to provide additional support to improve access to GP clinics in suburbs that need it the most.

The ACT government has invested close to one million dollars in this grant initiative to make it easier for people to find a local doctor and a local practice where they will receive the care they deserve, regardless of their personal circumstances.

More than \$600,000 has been awarded to the Interchange General Practice and Isabella Plains Medical Centre as part of this major investment in primary healthcare.

With this funding these two practices will expand their bulk billing health services in Tuggeranong.

\$500,000 will be going to the Interchange General Practice to cover the complete fitout for a new general practice which will focus on providing medical services to vulnerable people in our community.

The practice will provide medical services to people in need of support with:

- drug and alcohol dependency;
- issues of sexuality and gender diversity;
- chronic conditions; and
- mental health conditions.

I understand that the new practice will have seven to eight rooms with the capacity for up to 35,000 consultations per year when fully staffed.

The second recipient, Isabella Plains Medical Centre, will receive a grant of over \$100,000.

These funds will go towards an upgrade of its existing centre to improve access for clients with a disability and to expand the centre's bulk billed services.

The upgrade will include renovations and fitout of two rooms of the practice to allow for ease of access and to improve privacy for patients.

I have been told that the practice will also use this grant to improve the functionality of its website and to purchase medical equipment for use at outreach clinics and home visits, which will help the centre to extend its care to those unable to leave their homes.

These grants will not only improve access to a more affordable health care, but will also ensure that the people in our community who are going through complex health needs in their lives, have a convenient, reliable and high quality general practice nearby to turn to for help when they need it.

The ACT Health Directorate will also work with the Capital Health Network on ways to improve access to bulk billing general practices.

Canberra has some of the lowest bulk-billing rates in the country. By encouraging more GPs to bulk bill we can make it easier for people, in particular those most in

need, to find a local doctor who they can rely on regardless of their personal circumstances.

I am looking forward to seeing the new and improved practices up and running and delivering high quality general practice health care services to the Tuggeranong community.

I look forward to making further announcements on the GP grants over the next week.

More access to GP bulk billing in Tuggeranong

Tuggeranong is set to get a new general practice and an expansion of another general practice through the ACT Government's Bulk Billing General Practices Grant Fund.

More than \$600,000 has been awarded to the Interchange General Practice and Isabella Plains Medical Centre as part of this major investment in primary healthcare in Canberra's south, which will not only improve general practice facilities, but also make it easier for people in Tuggeranong to find a bulk billing GP in the area.

The Interchange General Practice will use its grant of \$500,000 to establish a new seven to eight room practice with a focus on bulk billed primary health care services for vulnerable people in our community.

The new practice will deliver up to 35,000 consultations per year when fully staffed. It will provide better medical services for people with drug and alcohol dependency, issues of sexuality and gender diversity, chronic conditions and mental health conditions.

The Isabella Plains Medical Centre will use its \$111,000 grant in a multifaceted way by upgrading its premises to improve access for clients with a disability and to expand its bulk billing, making its services more affordable.

The expansion of the practice will include the refurbishment of two rooms of the practice and the purchase of new equipment for use at outreach clinics and home visits, extending the Centre's remote care capabilities. It will also include a revamp of their website.

Minister for Health and Wellbeing Meegan Fitzharris said the grants were about incentivising more clinics and more doctors in Canberra's south to offer bulk billing to more patients, in particular those most in need.

"Canberra has some of the lowest bulk-billing rates in the country," Minister Fitzharris said.

"By encouraging more GPs to bulk bill we can make it easier for people, in particular for those most in need, to find a local doctor who they can rely on, regardless of their personal circumstances.

"Our GPs also play an important role in keeping Canberrans healthy and out of our hospitals, which is why improving access to GPs and affordable primary healthcare is so important.

"I look forward to making further announcements on the GP grants over the next week," Minister Fitzharris said.

It's great to be here again in Canberra's south to be announcing the expansion of local health services for the suburb of Coombs in the Molonglo Valley.

In 2016, the ACT Government made an election commitment to introduce an initiative to support bulk billing general practices in the ACT.

So I'm pleased to be here today to deliver on that promise and announce the third recipient of the Bulk Billing General Practices Grant Fund.

This \$350,000 grant, which is being awarded to the National Health Co-op, will mean better access to more affordable, local health care for people living in the Molonglo Valley area.

We know that our general practices play an important role in keeping Canberrans healthy. That is why we have been determined to provide additional support to improve access to GP clinics in suburbs that need it the most.

With the grant, the National Health Co-op is establishing a new multidisciplinary general practice right here in Coombs, taking the number of National Co-op clinics to nine in the ACT.

Canberra has some of the lowest bulk-billing rates in the country.

Through these grants the ACT Government is ensuring its citizens have better access to more affordable health care.

This is about offering bulk billed services that are convenient, reliable and high quality, for locals when they need them.

I am looking forward to seeing the new practice up and running and delivering high quality general practice health care services to the Molonglo Valley community.

Just last week I announced the two other successful recipients in Tuggeranong; the Interchange General Practice and the Isabella Plains Medical Centre.

These practices received over \$600,000 between them to establish a new general practice that bulk bills and to expand bulk billed services, respectively.

Ultimately this is about keeping people well and out of hospital, and our local GPs play a vitally important role in doing that task.

To have additional bulk billed services means we are giving people greater access to the primary health care services that they need at the right place and at the right time.

Better access to GP bulk billing in Coombs

The National Health Co-op will soon be offering more bulk billing services in the Molonglo Valley with the National Health Co-op receiving an ACT Government grant to establish a new GP clinic in Coombs.

Minister for Health and Wellbeing Meegan Fitzharris said \$350,000 in funding through the Bulk Billing General Practices Grant Fund has been awarded to the Co-op for their clinic in Coombs, making it easier for residents in Molonglo to find a local bulk billing doctor.

"The ACT Government is encouraging more GPs to bulk bill to make it easier for people, in particular those most in need, to find a local doctor who they can rely on, regardless of their personal circumstances," Minister Fitzharris said.

"The funding that has been provided to the Co-op will help the establishment and fit-out of the eleven room clinic in Coombs.

"The new clinic will not only incorporate bulk billing for a visit to the GP, but for other primary healthcare services as well, making it multidisciplinary.

"It will have a big impact on increasing the level of local healthcare available for residents in Molonglo."

Adrian Watts, Chief Executive Officer of the National Health Co-op, said the Co-op was strongly supportive of the Government's efforts to improve access to bulk billed primary health care services.

"This new clinic in Coombs, funded under this grant, will enable local residents of the growing Molonglo Valley to access affordable health care services much closer to home," Mr Watts said.

"The new clinic will have space for up to 10 bulk billing GPs as well bulk billing psychologists, dieticians, nurses and other allied health care providers.



ISSUE: SUPPORT FOR BULK BILLING GENERAL PRACTITIONERS

Talking points:

- The 2017–18 ACT Budget announced \$1.05 million (GST exclusive) over three years for the 'Better care when you need it—Support for bulk billing GPs' initiative as part of the ACT Government election commitment to deliver a grant scheme to support the establishment of bulk billing general practices in the ACT.
- The Bulk Billing General Practices Grant Fund aims to encourage the
 expansion or establishment of new general practices with a
 demonstrated commitment to bulk billing in the Tuggeranong and
 Molonglo Valleys. The aim is to provide residents in those areas with
 better access to affordable, connected, quality primary health care.
- Grant guidelines were developed in consultation with key stakeholders: Health Care Consumers' Association (HCCA); Australian Medical Association (AMA) ACT; and Capital Health Network (CHN).
- Applications have been assessed by a panel, including the key stakeholders above, and three grant recipients have been selected.
- On 19 and 22 October 2018, it was announced that a total of almost \$1 million in funding would be distributed between the three grant recipients, to establish two new general practices, one in Molonglo, and one in Tuggeranong, and to expand the services of an existing Tuggeranong general practice.
- All three grant recipients have a demonstrated commitment to bulk billing, particularly for vulnerable population groups.
