DECISION ON YOUR ACCESS APPLICATION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act) received by ACT Health Directorate (ACTHD) on Thursday 9 January 2020.

This application requested access to:

"All Canberra Health Services and/or ACT Health internal correspondence between/to and from executive level staff or clinical heads of departments from November 20 to the date of FOI acknowledgment relating to:

- smoke haze in Canberra Hospital or other health facilities.
- availability of P2 masks in Canberra
- smoke related ED admissions

AND all briefing notes prepared on the smoke haze, P2 mask availability, air purifiers availability and or health impacts of smoke."

I am an Information Officer appointed by the Director-General of ACT Health Directorate (ACTHD) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. ACTHD was required to provide a decision on your access application by **Thursday 21 May 2020**. This includes an extension of one month with your agreement.

I have identified 73 documents holding the information within scope of your access application. These are outlined in the schedule of documents included at <u>Attachment A</u> to this decision letter.

Decisions

I have decided to:

- grant full access to 33 documents; and
- grant part access to 40 documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request;
- The views of relevant third parties; and
- The Human Rights Act 2004.

Full Access

I have decided to grant full access to 33 documents at reference 2, 3, 5, 6, 13, 15, 18, 19, 27-30, 32, 33, 35-39, 44, 46, 47, 49, 50, 53-55, 57, 59, 64, 70 and 71.

Partial Access

I have decided to grant partial access to 40 documents at reference 1, 4, 7, 9-12, 14, 16, 17, 20-26, 31, 34, 40-43, 45, 48, 51, 52, 56, 58, 60-63, 65-69, 72 and 73.

Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the disclosure of the documents:

- Schedule 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability;
- Schedule 2.1(a)(ii) contribute to positive and informed debate on important issues or matters of public interest;
- Schedule 2.1(a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision;
- Schedule 2.1(a)(xi) reveal environmental or health risks or measures relating to public health and safety.

Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

• Schedule 2.2(a)(ii) prejudice the protection of an individual's right to privacy, or any other right under the *Human Rights Act 2004*;

The information that has been redacted is related to staff mobile numbers, personal information of employees of non-government agencies and third parties. On balance, I determined the information identified is contrary to the public interest and I have decided not to disclose this information.

Charges

Processing charges are not applicable to this request.

Disclosure Log

Under section 28 of the FOI Act, ACTHD maintains an online record of access applications called a disclosure log. The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. Your personal contact details will not be published.

Hi Tracey,

We spoke to ACTGAL and cross referenced the historical data. We note that the reporter was looking at <u>PM2.5</u> (smaller particulates). Our readings for dust come from <u>PM10</u>.

We have confirmed the following based on the reporters words for PM2.5:

- On 16 Dec 2018 : I can see that Civic had a reading of 174, Florey 140 and Monash 157. This is correct
- On 25 Jan 2019: I read that Civic hit 394 (actually off the chart), Florey 47 and Monash just 32. ACTGAL report this as a glitch because it was not a natural reading and it spiked and dropped down quickly over a two-hour period.
- On 13 Feb 2019: definitely sees a reading of 107 for Civic, 130 for Florey and 95 for Monash. <u>This is</u> <u>correct</u>.

The previous data provided by Ian for <u>PM10</u> is also correct.

The ACT Health Directorate's air quality monitoring stations are now registering high levels of dust particles reducing air quality across the territory to 'very poor' and 'hazardous' levels.

With air quality at these levels, all Canberrans are advised to limit vigorous physical activity outdoors.

People who are more sensitive to dust in the air, particularly those with asthma and other heart or lung conditions, should continue to take extra precautions. This includes taking medication as prescribed by their doctor and reducing exposure where possible, for example, by staying indoors with windows and doors closed.

Anyone with concerns about their health should seek medical advice from their health practitioner, and anyone experiencing wheezing, chest tightness or difficulty breathing should seek urgent medical assistance. In the event of a medical emergency call triple zero 000.

People can monitor air quality levels across the ACT by downloading the AirRater app (<u>https://airrater.org</u>). The Health Directorate is also continuing to monitor levels, and if there is a further decline in air quality, we will issue additional health advice.



Public Health Physician, Dr Vanessa Johnston says the ACT Health Directorate's air quality monitoring also indicates that these smoky conditions are forecast to remain until at least Wednesday.

"Due to the poor air quality, all Canberrans should avoid prolonged or heavy physical activity outside when there is smoke around. Anyone who is sensitive to the effects of smoke and air pollution should take measures to reduce their exposure," Dr Johnston said.

"People sensitive to air pollution, including those with chronic heart or lung conditions, children 14 years or younger, pregnant women and people over 65 years should avoid all physical activity outside.

ACT Health alert: Smoke and extreme heat impacting Canberra

The ACT Health Directorate are today upgrading health advice to the community due to the deterioration of air quality across Canberra from smoke.

ACT Public Health Physician, Dr Vanessa Johnston said the impact of the smoke haze on air quality is being intensified by the extreme heat conditions that are forecast to continue over the coming days.

"Our air quality is being significantly impacted by this combination of bushfire smoke, extremely high temperatures and lack of wind, which means the smoke is lingering," Dr Johnston said.

"During these periods of heavy smoke haze, all Canberrans are advised to avoid physical activity outside.

"People who are sensitive to smoke, especially those with pre-existing heart and lung conditions, should take extra care and stay indoors where possible and take medication prescribed by their doctor."

People who are sensitive to smoke and air pollution can also be more vulnerable to heat-related illness. This includes:

- people with heart or lung conditions (including asthma)
- children aged less than 14 years
- pregnant women, and
- people over 65 years of age.

"With the extreme heat, it is also important for everyone to be aware and prepare for the hot temperatures," Dr Johnston said.

"During these times, it is vital for people to stay hydrated and to keep cool.

"People should make sure they are drinking plenty of cool water – don't wait until you are thirsty. People should also avoid being outdoors in the hottest parts of the day.

"We are strongly advising people more vulnerable to these conditions to take extra care while these heavy levels of smoke are lingering. This includes remaining indoors and keeping activity levels as low as possible.

"Anyone with a heart or lung condition should take their medication as prescribed by their doctor. People with asthma should follow their asthma action plan.

"Anyone with concerns about their health should seek medical advice from their doctor. And anyone experiencing wheezing, chest tightness or difficulty breathing should seek urgent medical attention and in the event of a medical emergency call triple-zero (000)."

Canberra Health Services Chief Operating Officer Elizabeth Chatham said the Emergency Department at Canberra Hospital had seen a small increase in respiratory-related presentations today.

"We would like to reinforce ACT Health's advice to avoid outside physical activity, stay indoors with windows and doors closed and use recycled air conditioning," Ms Chatham said.

"We can implement plans should we see a spike in presentations for asthma and respiratory related illnesses, however this is not necessary at this stage.

"If you have an appointment with any of our clinics today and feel well enough to come in, please attend your appointment as planned. "However, if you are sensitive to smoke you should take measures to reduce your exposure. This includes staying indoors (with windows and doors closed) where possible. Canberra Health Services staff will work with you to reschedule your appointment if you're unable to attend due to the smoke."

The ACT Health Directorate is continuing to monitor the air quality in the ACT and will advise the public of additional public health advice when needed and as information becomes available.

 - Teleconference held with the Security and Emergency Management Branch of the Justice and Community Safety Directorate (JCSD) at 14.25hrs.
 - JCSD has advised that the BBL match is due to commence at 18.10hrs, with crowds expected to arrive from 17.30hrs
 - The estimated crowd is 6000 7000 people.
 - Free water will be available for the crowd at the bar and also from 2 bubblers on-site. Bottled water will also be available to distribute to the crowd if necessary.
 - There will be an ambulance on site, additional first-aid points have been added and there will be 2 air-conditioned triage first-aid tents on site.
 - ACT Health has distributed the most recent health alert to JCSD, who will contact Ticketek to arrange for an email to be sent to ticket holders referring to current health advice from ACT Health.
 - The match umpire will have responsibility for assessing risk to the cricket players during the match and can stop play if deemed necessary.

3. EVALUATION / THREAT ANALYSIS:

- Air quality to continue to be hazardous this evening and into tomorrow morning. All appropriate actions in coordination of response and public/stakeholder messaging have been undertaken.
- CHO/HEMU/media on-call officers will continue to monitor the situation over the weekend.
- This is the final sitrep. HECC stood down at 1515hrs.


