# DECISION ON YOUR ACCESS APPLICATION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act) received by ACT Health Directorate (ACTHD) on Tuesday 22 December 2020.

This application requested access to:

*"Correspondence to and from the Chief Health Officer, including emails, and documents prepared, between December 17 2020 and December 21 2020 inclusive on the following topics:* 

- advice on the effect of the Northern Beaches COVID outbreak on the ACT
- measures regarding stopping travellers from areas designated as COVID hotspots from going to the ACT
- Correspondence to and from ACT Policing on border measures
- Correspondence regarding the Illawarra-Shoalhaven region."

I am an Information Officer appointed by the Director-General of ACTHD under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. ACTHD was required to provide a decision on your access application by **Friday 12 February 2021.** 

I have identified 101 documents holding the information within the scope of your access application. This is outlined in the schedule of documents included at <u>Attachment A</u> to this decision letter.

# **Decisions**

I have decided to:

- grant full access to 32 documents;
- grant partial access to 57 documents; and
- refuse access to 12 documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request;
- Views of relevant third parties; and
- The Human Rights Act 2004.

# Full Access

I have decided to grant full access to 32 documents at reference 1-3, 6, 12, 13, 15, 32, 35-37, 39, 43-45, 51, 52, 54, 55, 58, 59, 62, 65-67, 69, 71, 74, 88, 89, 96 and 97.

# Partial Access

Documents at reference 5, 68 and 85 contain information disclosure of which is taken to be contrary to the public interest as set out in Schedule 1, 1.2 Information subject to legal professional privilege.

I have decided to grant partial access to 68 documents at references 4, 5, 7-11, 14, 20-26, 28-31, 33, 34, 38, 40-42, 46-50, 53, 56, 57, 60, 61, 63, 64, 68, 70, 75, 79-81, 83-86, 90-95 and 98-100.

# Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the disclosure of the documents:

Schedule 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability.

# Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

- Schedule 2.2(a)(ii) prejudice the protection of an individual's right to privacy, or any other right under the *Human Rights Act 2004;*
- Schedule 2, 2.2(a)(x) prejudice intergovernmental relations; and
- Schedule 2, 2.2(a)(xi) prejudice trade secrets, business affairs or research of an agency or person.

Consistent with section 38 of the FOI Act, Information Officers must take reasonable steps to consult with relevant third parties such as the Commonwealth before deciding to give access to information. As such, ACTHD conducted a consultation process across jurisdictions and relevant third parties and considered any objections put forward.

The information that has been redacted is related to ACT Government employees' mobile numbers and the personal information of non- ACT Government individuals including third parties. These contact details have been redacted as this does not further the objects of the Act. External employee names do not add anything of substance to open discussion of public affairs and in most cases these employees are not the decision makers in these matters. Third party feedback states that exemption of public servant names and contact details below the Senior Executive Service (SES) level is a standard practice. Additionally, non-SES staff who perform administrative roles rather than decision making, have been subject to inappropriate telephone calls from members of the public relating to the coordination of COVID-19 responses. In the current circumstances, it is reasonable to expect that if the names of non-SES employees are disclosed, this could result in interference with the personal privacy of individuals, and potentially prejudice the health, safety and wellbeing of those officers. Therefore, on balance, I determined the information identified is contrary to the public interest and I have decided not to disclose this information.

Document at reference 34 includes a redaction made to a Qantas password, the disclosure of which could reasonably be expected to prejudice the business affairs of the company. Therefore, on balance, I determined the information identified is contrary to the public interest and I have decided not to disclose this information. Further redactions have been made to the Australian Health Protection Principal Committee's (AHPPC) meeting papers. These documents were designed to provide advice and guidance on the deliberative process of the AHPPC with State Governments and the Commonwealth Government. ACTHD is not the author of these documents but is privy to hold this information due to its representation at this Committee. All documents include deliberative material and material communicated in confidence between governments in response to the coronavirus public health emergency. These meetings papers were drafted for the purpose of deliberations by the AHPPC and were communicated and recorded in a confidential forum. The release of this information could reasonably be expected to damage the intergovernmental relationships between the ACT Government and other jurisdictions. On balance, I determined the information identified is contrary to the public interest and I have decided not to disclose this information.

# **Refused Access**

Documents at reference 16-19, 27, 72, 73, 76-78, 82, 87 contain information disclosure of which is taken to be contrary to the public interest as set out in Schedule 1, 1.2 Information subject to legal professional privilege.

Document at reference 101 contains confidential public health related information communicated between Governments. The release of this information could reasonably be expected to damage the intergovernmental relationships between the ACT Government and other jurisdictions. On balance, I determined the information identified is contrary to the public interest and I have decided not to disclose this information.

# **Charges**

Processing charges are not applicable to this request.

# **Disclosure Log**

# **Ombudsman review**

Overnight we have responded to a cluster in the Northern Beaches LGA by strengthening our travel and health advice. There is clear community transmission in this LGA with 17 cases to date, 2 main transmission events/locations (11th RSL, 13th Bowling Club), contact tracing continuing with more cases and venues to be identified.

We will go strong with our protective measures while further assessment is conducted of the extent of transmission in Sydney.

Key messages:

- do not travel to Northern Beaches LGA
- If in this LGA from 11 Dec must self-quarantine and get tested
- Additionally, if you have been in one of the identified locations please call ACT Health

Actions:

- Tracey road signage clear specific message on road in and out to Sydney re northern beaches...
- Merryn/Seriden organise for exemption database to be checked for a government official who arrived flight from LA on 1 Dec into Sydney and exempted from hotel quarantine... check if this person completed quarantine, if they were exit tested and result please
- Vanessa J organise follow up with NSW about ACT contacts
- VJ i offered our contact tracers to NSW (for practice...)
- VJ advice to CHECC, RACF etc to exclude northern beaches LGA. We will not provide the relaxation advice to RACF's given this issue.
- Note there is no plan to introduce any border controls, nor the declaration process



The use of a hire care will be considered "appropriate transportation" for transporting crew between a vessel and a quarantine/medical facility or an airport.

The Minister has made the <u>Public Health (COVID-19 Air Transportation Quarantine)</u> Order (No 4) 2020 which commenced on 14 December.

The No 4 Order continues the existing restrictions in the current Public Health (COVID-19 Air Transportation Quarantine) Order (No 3) 2020, subject to certain amendments:

- a "designated quarantine facility worker" cannot carry out services, or continue to carry out services, at a quarantine facility unless the person has been tested for COVID-19 in accordance with the NSW Testing Program for that class of workers. Similar restrictions apply to a "designated transportation worker". The NSW Testing Program will be set out in the Quarantine Worker Surveillance and Testing Program, which must be approved by the Chief Health Officer. The NSW Testing Program sets out when different categories of worker must be tested if a worker in that category is not tested in accordance with the Program, they cannot provide services at the quarantine facility until they have been tested. On 14 December, the only category of workers that will be required to be tested in order to provide services will be persons providing security services (but not police officers). The category of workers included in the Testing Program may expand as time goes on.
- The No 4 Order also requires a person who leaves a guarantine facility because of an emergency to comply with the directions of the Commissioner of Police.
- The Order also requires designated air crew who are self isolating to comply with the *Air Transportation Guidelines* as updated from time to time.

The No 4 Order will commence at the beginning of 14 December 2020.

The Minister has made the <u>Public Health (COVID-19 Sydney New Year's Eve Arrangements) Order</u> 2020

- The Order will set the arrangements that will apply to "restricted zones" and "declared zones" during the NYE period. The NYE period is 5pm 31 December to 5 am 1 January 2020. The restricted zones and declared zones are set by a map (you can find details at <a href="https://www.nsw.gov.au/covid-19/covid-safe/major-events/new-years-eve">https://www.nsw.gov.au/covid-19/covid-safe/major-events/new-years-eve</a>).
- A person can only enter a restricted zone during the NYE period if they fall within a relevant class (residents and their visitors, attendees of a registered event, persons attending work) AND the person holds an entry pass.
- A person in a declared zone or a restricted zone must leave the area if asked to do so by a
  police officer or an authorised officer (for residents, leave the area means go back to their
  place of residence).
- A person must also provide true and accurate information to a police officer or authorised officer if asked in order to determine whether the person should be in the restricted zone.
- People will be able to seek an entry pass for a restricted zone from 7 December.

The Minister has made the <u>Public Health (COVID-19 Restrictions on Gathering and Movement)</u> <u>Order (No 7) 2020</u> which commenced on 7 December.

The No 7 Order repeals the Public Health (COVID-19 Restrictions on Gathering and Movement) Order (No 6) 2020 and puts in place an easing of COVID-19 related restrictions.

Under the No 7 Order:

- There can be up to 50 residents at a premises
- Up to 100 people can gather in an outdoor public place, subject to a number of exemptions including
  - o Gatherings on premises that are required to have a COVID-19 safety plan
  - o up to 3,000 people (subject to 1 person per 2 square metres) can gather for
  - community sport, outdoor performances & rehearsals, and outdoor protests

# Confirmed cases update

There have been no new cases of COVID-19 recorded in the ACT in the past 24 hours, leaving the ACT's total at 117. There are no active cases in the ACT.

A total of 114 cases have recovered from COVID-19 in the ACT.

There are no COVID-19 patients in Canberra hospitals.

The ACT has recorded three (3) deaths.

The number of negative tests recorded in the ACT is now 127,532

### Update on travel and health advice for Northern Beaches outbreak

There are now 28 cases confirmed cases linked to the Northern Beaches, as reported by NSW Health on Friday morning.

Our travel and health advice to the community remains the same. We are asking people to do three things:

- 1. Do not to travel to the Northern Beaches area of Sydney at this time. People from the Northern Beaches area should also not travel to the ACT.
- 2. Anyone who has visited the Northern Beaches area from Friday 11 December 2020 must self-quarantine for 14 days from the date they were last there and get tested, even if they do not have symptoms. People must stay in quarantine for the whole 14 days even if they have a negative test result.
- Anyone who has been in an <u>affected location identified by NSW Health</u> should follow the advice on the NSW website and contact the ACT Health COVID-19 team on (02) 5124 9213 for further advice.

Given the increase in cases and the evidence of community transmission, a new Public Health Direction that has been put in place from 11.59am this morning, declares the Northern Beaches Local Government Area as a COVID-19 affected area. Under the Direction, those who have been in the Northern Beaches from Friday 11 December 2020 are legally required to self-quarantine for 14 days from the date they were last there. Further information on requirements for quarantine is on the ACT COVID-19 website. With demand for testing currently at high levels, we ask those impacted by this direction to immediately quarantine, organise their testing for later in the day and be patient with staff at our testing clinics. For information on testing clinics please visit the <u>COVID-19 website</u>.

'We are acting quickly to respond to this outbreak as is NSW Health and we are working closely with our counterparts in NSW. We know this is difficult but we need the community to work with us and follow the health and travel advice closely," Chief Health Officer Dr Kerryn Coleman said.

This remains a rapidly evolving situation and we will keep the community informed as more information comes to hand.

'As we make plans to come together with our family and friends in the coming weeks, or travel over the summer holidays, we must be COVID-Safe and get tested, even with the nildest of symptoms," Dr Coleman said.



This has prompted a new Public Health Direction to be issued today by the ACT Chief Health Officer that declares the Northern Beaches Local Government Area as a COVID-19 affected area.

The Chief Health Officer is asking us to do three things:

- 1. Do not to travel to the Northern Beaches area of Sydney at this time. People from the Northern Beaches area should also not travel to the ACT.
- 2. Under the Direction, anyone who has visited the Northern Beaches area from Friday, 11 December 2020 is now legally required to self-quarantine for 14 days from the date they were last there and get tested, even if they do not have symptoms. People must stay in quarantine for the whole 14 days, even if they have a negative test result. Further information on requirements for quarantine is on the <u>ACT COVID-19 website</u>.

3. In addition to the Northern Beaches area, anyone who has been in an <u>affected location</u> <u>identified by NSW Health</u> should follow the advice on the NSW website and contact the ACT Health COVID-19 team on (02) 5124 9213 for further advice.

The Chief Health Officer has asked anyone impacted by this Direction to organise their testing for later in the day and be patient with staff at our testing clinics. For information on testing clinics please visit the <u>COVID-19 website</u>.

For information on ACT Public Service staff arrangements for COVID-19 please visit the <u>ACTPS</u> <u>Employment Portal</u>.

At this time I would like to remind anyone planning to travel during the holiday season to maintain your personal responsibilities:

The COVID-19 situation can change rapidly and as such, advice for high-risk settings is subject to change regularly. ACT Health will continue to keep you updated through these Chief Health Officer alerts.

#### Key information for general practitioners:

- Current geographical areas of risk for COVID-19 transmission are:
  - <u>Sydney Northern Beaches Local Government Area.</u>
- The ACT border is open to all Australian states and territories. People in ACT are advised not to travel to Sydney Northern Beaches Local Government Area.
- A Public Health Direction mandating quarantine for individuals who are close contacts of COVID-19 cases remains in place. This may include people who attended specific venues on the same date/time as a confirmed case; these are listed <u>here</u>.
- A new Public Health Direction came into effect today, requiring anybody who has been in <u>Sydney Northern</u> <u>Beaches Local Government Area</u> from the 11<sup>th</sup> of December to go into quarantine for 14 days after last being in the area and get tested.
- GPs and other community health practitioners who have recently been in a geographical area of risk (see above), but who are not in quarantine under a Public Health Direction, should be particularly vigilant for symptoms of COVID-19. If symptoms develop, they should immediately self-isolate and arrange to get tested for COVID-19.
- Health practitioners should actively seek a patient's travel history and determine if they have been in a geographical area of risk (see above). If yes, the practitioner should be alert to even mild symptoms of COVID-19 and have a low threshold for testing, using appropriate PPE.

# Public health advice for high-risk settings and health professionals regarding interstate COVID-19 outbreaks (new information in red)

ACT Health

## Key Points

- The ACT border is open to every Australian state and territory.
- There is a current outbreak of COVID-19 cases associated with the Sydney Northern Beaches Local Government Area (LGA).
- A Public Health Direction will be in effect from today (at 11.59 AM on 18 December 2020) mandating testing and quarantine for anyone in the ACT who has been in Sydney Northern Beaches LGA from the 11<sup>th</sup> of December. Quarantine is required for 14 days from the date they were last there.
- Anyone who has been in the Sydney Northern Beaches LGA (now classified as an area of geographical risk) in the previous 14 days should not visit or work in a high-risk setting for 14 days after leaving the area.
- Anyone in the ACT who has been to any listed <u>locations</u> at the time specified by NSW Health must follow NSW Health advice AND call ACT Health on (02) 5124 9213 for further advice.

## What is the situation?

- There is a current outbreak of COVID-19 cases associated with the Sydney Northern Beaches LGA. Suburbs in the Sydney Northern Beaches LGA are now classified as an area of geographical risk and are listed <u>here</u>.
- The ACT border remains open to every Australian state and territory.
- Canberrans are being advised not to visit the Northern Beaches area of Sydney at this time.
- Anyone in the ACT who has travelled to the Sydney Northern Beaches LGA from the 11<sup>th</sup> of December must get tested and self-quarantine for 14 days after leaving the area. A Public Health Direction comes into effect today (at 11.59 AM on 18 December 2020) mandating quarantine.
- Anyone in the ACT who has been to any listed <u>locations</u> at the times specified by NSW must follow NSW Health advice AND call ACT Health on (02) 5124 9213 for further advice.
- Anyone in the ACT who has recently travelled interstate, including to Sydney, should keep up to date with public health alerts from the jurisdiction they travelled from.
- The advice in this Chief Health Officer alert will be reviewed regularly. The geographical areas of risk in Australia remain subject to change, depending on the COVID-19 situation.

## ACT Public Health Directions regarding interstate COVID-19 outbreaks

- Anyone who has been in close contact with a confirmed COVID-19 case during the case's infectious period must guarantine until 14 days after their last contact with the case.
  - Some people who attended specific public locations at the same time as a confirmed COVID-19 case may be considered close contacts. People who have attended any of the listed "self-isolate and get tested" locations on the NSW Health page must get tested and quarantine for 14 days AND call ACT Health (02) 5124 9213 for further advice.
  - A Public Health Direction is in effect from today (at 11.59 AM on 18 December 2020) mandating testing and quarantine for anyone in the ACT who has been in Sydney Northern Beaches LGA from the 11th of December. Quarantine is required for 14 days after leaving the area.

## What are high-risk settings?

- A high-risk setting is defined as a setting where there are a large number of people who are vulnerable to severe disease from COVID-19 (e.g. due to age or chronic medical conditions), and/or where there is a higher risk of COVID-19 transmission due to close proximity and difficulties maintaining physical distancing.
- These high-risk settings are:
  - Hospitals
  - o Residential aged care facilities
  - o Correctional facilities
  - Residential accommodation facilities that support people who require frequent, close personal care and who are vulnerable to severe disease

## Advice for high-risk settings

- Anyone who is in quarantine under a Public Health Direction (see above) must not visit or work in a high-risk setting.
- Anyone who has been in a geographical area of risk (see above) should not visit or work in a high-risk setting for 14 days since leaving these areas.
- If facilities identify staff who have been in the Sydney Northern Beaches LGA since the 11<sup>th</sup> of December, they should advise their staff to go into quarantine. If staff were in the Sydney Northern Beaches LGA prior to the 11<sup>th</sup> of December, they should not work in a high-risk setting for 14 days since leaving the area.
- If someone is excluded from visiting or working in a high-risk setting, but is seeking to visit on compassionate grounds, or to work because they are deemed essential (e.g. someone with expertise that cannot be sourced elsewhere):
  - If they are <u>not</u> in quarantine under a Public Health Direction (see above), this should be considered following a risk assessment, in consultation with ACT Health.



 If they are in quarantine under a Public Health Direction (see above), they will need to apply for an exemption at <u>covid19.act.gov.au/exemption-application</u>.

### Advice for staff providing home-based aged care, disability and other support services

- Anyone who is in quarantine under a Public Health Direction (see above) should not provide home-based aged care, disability or other support services.
- If organisations identify staff who have been in the Sydney Northern Beaches LGA since the 11<sup>th</sup> of December, they should advise their staff to go into quarantine. If staff were in the Sydney Northern Beaches LGA prior to the 11<sup>th</sup> of December, they should not provide homebased aged care, disability or other support services for 14 days since leaving the area.
- If the service deems it is essential for the staff member to continue in their role:
  - If they are <u>not</u> in quarantine under a Public Health Direction (see above), the staff member's manager should undertake a risk assessment to determine whether it is appropriate for the staff member to return to work. Considerations include the staff member's risk of exposure to COVID-19, duration of close physical contact with clients and client vulnerability to COVID-19. The risk assessment should be done in consultation with ACT Health.
  - If they are in quarantine under a Public Health Direction (see above), they will need to apply for an exemption at covid19.act.gov.au/exemption-application.

## Advice for general practitioners and other community health practitioners

- Anyone who is in quarantine under a Public Health Direction (see above) must not work in a community health setting, unless ACT Health grants them an exemption to do so.
- GPs and other community health practitioners who have been in a geographical area of risk (see above), but who are not in quarantine under a Public Health Direction, should be particularly vigilant for symptoms of COVID-19. If symptoms develop, they should immediately self-isolate and arrange to get tested for COVID-19.
- Health practitioners should actively seek a patient's travel history and determine if they have been in the Sydney Northern Beaches LGA since the 11<sup>th</sup> of December and advise them to go into quarantine and get tested.

#### National:

- At 1100hrs 18 December 2020, NSW reported <u>28 locally acquired cases</u> in the last 48 hours:

  - o Advice to Northern Beaches LGA residents to wear masks, get tested, and stay home;
  - NSW will provide daily updates at 1100hrs.
- Jurisdictions have implemented restrictions for all travellers who have travelled (from 11 December), or will travel, from the Northern Beaches LGA to self-isolate for 14 days and get tested (incl. WA).
- <u>Queensland</u> and <u>Northern Territory</u> declared the Northern Beaches LGA a hot spot and travellers arriving after 0100hrs 19 December must enter hotel quarantine at their own expense and get tested.
- <u>Tasmania</u> declared the Northern Beaches LGA as a high-risk and travellers from this LGA will have to apply for exemption to travel to Tasmania.
- <u>Victoria</u> implemented a <u>permit system</u> from 19 December for anyone entering from NSW, with all travellers in the Northern Beaches LGA from 11 December not permitted to enter.
- <u>South Australia</u> implemented a <u>permit system</u> from 19 December for anyone entering from interstate and all travellers in the LGA since 11 December not permitted to enter.
- On 18 December 2020, the Minister for Health <u>announced</u> the Chief Medical Officer has declared the Northern Beaches LGA a hot spot for Commonwealth support (e.g. PPE stock, contact tracing etc).
