DECISION ON YOUR ACCESS APPLICATION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by Canberra Health Services (CHS) on **Friday 22 April 2022**.

This application requested access to:

'Information regarding the Dhulwa Mental Health Unit and:

- a. Nurses and Nursing; and/or
- b. Work Health and Safety; and/or
- c. Occupational Violence; and/or
- d. Workplace Culture; and/or
- e. Human Rights.

Documents requested:

- 1. All relevant correspondence, inclusive of any attachments or other relevant documents such as briefings or advice, between (to and from) CHS and Worksafe ACT from 1/10/2021-21/04/2022.
- 2. All relevant correspondence, inclusive of any attachments or other relevant documents such as briefings or advice, between (to and from) CHS to the Office of the ACT Minister for Mental Health from 1/10/2021-21/04/2022.
- 3. All relevant correspondence, inclusive of any attachments or other relevant documents such as briefings or advice, between (to and from) CHS and the ACT Health Directorate from 1/10/2021- 21/04/2022.
- 4. All relevant correspondence, inclusive of any attachments or other relevant documents such as briefings or advice, between (to and from) CHS and the ACT Human Rights Commission from 1/10/2021-21/04/2022.'

I am the Information Officer appointed by the Chief Executive Officer of Canberra Health Services (CHS) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. CHS was required to provide a decision on your access application originally by **Monday 23 May 2022** and after an agreed extension changed to **Wednesday 15 June 2022**.

I have identified 59 documents holding the information within scope of your access application. These are outlined in the schedule of documents included at <u>Attachment A</u> to this decision letter.

Decisions

I have decided to:

- grant full access to 13 documents; and
- grant partial access to 46 documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request;
- The views of relevant third parties; and
- The Human Rights Act 2004.

Full Access

I have decided to grant full access to 13 documents at references 1-2, 4, 10, 16, 23, 26-27, 30, 39-40 and 47-48.

Partial Access

I have decided to partially grant access to 46 documents that contains information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in section 17 of the Act.

Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the disclosure of the documents:

- Schedule 2, 2.1 (a)(i) promote open discussion of public affairs and enhance the government's accountability;
- Schedule 2, 2.1 (a)(ii) contribute to positive and informed debate on important issues or matters of public interest; and
- Schedule 2, 2.1 (a)(iv) ensure effective oversight of expenditure of public funds.

Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

- Schedule 2, Schedule 2.2 (a)(ii) prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2004*; and
- Schedule 2, 2.2 (a)(xv) prejudice the management function of an agency or the conduct of industrial relations by an agency.

Documents at references 3, 8-9, 11-15, 17-22, 24-25, 28-29, 31-38, 41-46 and 49-59 are partially comprised of personal information of ACT Government employees and members of the public. The redacted information would not provide any government information pertinent to your request and therefore, I have decided this factor outweighs the public interest factors in the disclosure of this information.

Documents at references 5-7 are partially comprised of personal information of an ACT Government employee and a member of the public. These documents are also partially comprised of information that would prejudice the management function of an agency or the conduct of industrial relations by an agency.

I have given significant consideration to the factors favouring disclosure and I believe the factors favouring non-disclosure outweighed these as the information requested. It could reasonably be expected to have a detrimental effect for the agency's future management of complex staffing matters and patient care. The disclosure of identities of individuals could be damaging to those involved and discourage staff to not proactively voice concerns when such matters arise.

Therefore, I have determined the information identified is contrary to the public interest and I have decided not to disclose this information.

Multiple documents contain Health Records. Section 12 of the FOI Act outlines that this Act does not apply to information in a health record. Health information has been redacted to disclose access to government information where possible.

Charges

Processing charges are not applicable to this request.

Disclosure Log

Under section 28 of the FOI Act, CHS maintains an online record of access applications called a disclosure log. The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. Ombudsman review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the FOI Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in ACT Health's disclosure log, or a longer period allowed by the Ombudsman.
