### **DECISION ON YOUR ACCESS APPLICATION**

Our reference: CHSFO123-24.50

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by Canberra Health Services (CHS) on **Wednesday 24 April 2024**.

This application requested access to:

'All documents prepared in relation to providing a media statement to The Canberra Times on Tuesday, April 23, 2024, regarding the cost per patient at ACT's Walk-In centres, percentage of inbound and outbound patients redirected from these centres to EDs, and the last time these centres were reviewed'.

I am an Information Officer appointed by the Chief Executive Officer of Canberra Health Services (CHS) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. CHS was required to provide a decision on your access application by **Friday 7 June 2024**.

I have identified 22 documents holding the information within scope of your access application. These are outlined in the schedule of documents included at <u>Attachment A</u> to this decision letter.

## **Decisions**

I have decided to:

- grant full access to 2 documents; and
- grant partial access to 20 documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request; and
- The Human Rights Act 2004.

### **Full Access**

I decided to grant full access to 2 documents at references 17 and 21.

### **Partial Access**

The documents at references 1-16, 18-20, and 22 are partially comprised of information containing the mobile phone numbers of ACT Government employees and personal details of non-ACT Government employees.

The document at reference 9 is also partially comprised of information that may prejudice the business affairs of the ACT Government.

### Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the disclosure of the documents:

- Schedule 2, 2.1 (a)(i) promote open discussion of public affairs and enhance the government's accountability; and
- Schedule 2, 2.1 (a)(ii) contribute to positive and informed debate on important issues or matters of public interest.

### Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

- Schedule 2, 2.2 (a)(ii) prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2004*; and
- Schedule 2, 2.2 (a)(xi) prejudice trade secrets, business affairs or research of an agency or person.

On balance, the factors favouring disclosure did not outweigh the factor favouring non-disclosure as the redacted information under the test set out in section 17 of the Act. Therefore, I determined the information identified is contrary to the public interest and I have decided not to disclose this information.

## **Charges**

Processing charges are not applicable to this request.

## **Disclosure Log**

Under section 28 of the FOI Act, CHS maintains an online record of access applications called a disclosure log. The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. Your personal contact details will not be published.

# Media dot points – ACT Urgent Care Clinics

- From today, ACT Walk-in Centres will become part of the national network of Medicare
  Urgent Care Clinics (UCCs) thanks to a Commonwealth investment of \$7.1 million over the
  next three years.
- This investment from the Commonwealth builds on the success of our nurse-led Walk-in Centres, recognising the importance of nurse-led care as part of an overall system approach in the ACT.
- The funding to integrate the Walk-in Centres with the Urgent Care Clinic network will:
  - Increase the number of Nurse Practitioners and Advance Practice Nurses working across all five of our Walk-in Centres. 3 new Nurse Practitioners will ensure coverage across all hours of operation and 3 new Advance Practice Nurses will enhance training pathways.
  - Provide more equipment for the centres, which over time will see a wider range of conditions treated at the Walk-in Centres. This includes:
    - 2 slit lamps and 2 tanometers for the Weston and Belconnen Walk-in Centres for eye examinations and removal of foreign objects in the eyes,
    - 5 handheld ultrasound machines for each Walk-in Centre used in the examination of lacerations and other wound types, and
    - 1 handheld vascular doppler for the Weston Walk-in Centre for investigating blood flow and thrombosis.
  - Extend the scope of services at the Weston Creek Walk-in Centre with an advanced scope physiotherapist to treat patients with musculoskeletal injuries. The physiotherapist will also be able to provide virtual assessments and support for nursing staff in other Walk-in Centres if appropriate to the condition.
  - Expand the operating hours of the Weston Creek Medical Imaging Service to provide afterhours imaging, with funding for an additional sonographer and radiographer.
- This funding will see access to health care for non-life threatening illness and injury
  expanded across our much-loved Walk-in Centres. For example, the extension of services to
  be offered at the Weston Creek Walk-in Centre, will see Canberrans able to receive
  assessment, medical imaging, and treatment for a minor injury all in the same location,
  without the need to go to the hospital.
- The ACT Government has worked closely with the Commonwealth to ensure this investment is well integrated into our current Walk-in Centre model and responds to the needs of the ACT community.
- Walk-in Centres are already able to treat a wide variety of urgent but not life-threatening conditions including asthma, bites, minor head injuries and wound care.
- With the funding agreement now in place, Canberra Health Services has commenced the recruitment of new staff and purchase of new equipment.
- It is expected the full scope of additional services will be available from early 2024, and we will be updating the community when these services become available.
- Over time, the implementation of this funding will also enable an enhancement to the scope of conditions able to be treated at our Walk-in Centres. For example, treatment for shoulder injuries, male urinary tract infections, injury in pregnancy and screening for sexually transmitted infections.
- Nurse-led Walk in Centres are open seven days a week, including public holidays.

# **Supporting Q&A**

### Q: How will Walk-in Centres be expanded?

- The Medicare UCC funding will expand our Walk-in Centre services by:
  - increasing the number of nurses across the centres ensuring there is nurse practitioner coverage across all hours of operation,
  - o providing more equipment,
  - o providing a physiotherapist at Weston Creek Walk-in Centre, and
  - o improving access to after-hours imaging with more medical imaging staff at the Weston Creek imaging service.
- The nurses at the Walk-in Centres are already able to treat a wide variety of urgent but not life-threatening conditions including asthma, bites, minor head injuries and wound care.
- Over time, the implementation of the funding will also enable an enhancement to the scope
  of conditions able to be treated at the Walk-in Centres. For example, treatment of shoulder
  injuries and fractures, male urinary tract infections, treatment of minor illness and injury in
  pregnancy and screening for sexually transmitted infections.

### Q: What are the next steps for the ACT in implementing the Medicare UCC funding?

- With the funding agreement now in place, Canberra Health Services has commenced the recruitment of new staff and the purchase of new equipment.
- At this stage, it is expected the full scope of additional services will be available from early 2024.
- We will be updating the community when these services become available.

### Q: Why are GPs not part of the ACT UCCs?

- Our GPs are an incredibly important part of our primary health care network in the ACT. They play a central role in providing ongoing care to people and are often the first point of contact for patients within the health care system.
- We have had to think innovatively about how we implement the UCC model given the unique context that we have in the ACT. Key contextual factors considered included our low ratio of GPs per 100,000, which is indeed the lowest in the country.
- Our Walk-in Centres are an important part of an overall system approach, and this new
  funding will increase their capacity to enable better access for Canberrans to urgent care
  when they need it (in particular with extended hours), which is a primary aim of the
  Medicare UCC program.
- We will continue to work closely with community-based health services, including general practitioners, to ensure we are delivering an integrated health system where Canberrans can access the right care in the right place and at the right time.

## How will the Medicare UCC model be integrated in the Walk-In Centres?

 The ACT Government has worked closely with the Commonwealth to ensure this investment is well integrated into our current Walk-in Centre model and responds to the needs of the ACT community.

- The Walk-In Centres will remain nurse led; with this funding increasing the number of nurses
  and allied health professionals to boost coverage at all centres and allow for the purchase of
  more equipment. This will enable a wider range of conditions to be treated overtime and
  help to reduce escalations to emergency departments.
- With the funding agreement now in place, Canberra Health Services has commenced the recruitment of new staff and the purchase of new equipment.
- Implementing UCCs into Walk-in Centres, will ensure we are not fragmenting urgent care services in the ACT, which will in turn help to reduce confusion for Canberrans, who are already very familiar with Walk-in Centres.

### How much funding is being provided to establish ACT UCCs?

- The Commonwealth is contributing \$7.1 million over three years to support the integration of its Medicare UCCs program in the ACT, through our already established Walk-in Centres.
- As part of this funding, the ACT Government will receive yearly operating funding to cover basic staffing (nurse and administrator) sufficient to meet expected demand.

### What engagement with stakeholders has occurred on the ACT UCC model?

- Throughout the year, there have been ongoing conversations with local health stakeholders to engage with them on the ACT UCC model.
- This includes unions and other staff representative bodies, health consumer representatives and primary health care representative bodies.
- The ACT Government in partnership with the Commonwealth, will be holding a Webinar at
  the beginning of November with the broader GP network in the ACT and other interested
  health professionals. This will be an opportunity to learn more about the UCC model and
  how the integration of this model with our Walk-in Centres will support our primary care
  network.

### Is this an evidence-based model?

- ACT Emergency Departments have experienced significant growth in presentations in the past decade, averaging 3.4% growth per year between 2004-05 and 2020-21.
- Walk-in Centres were introduced in the ACT in 2010 to help alleviate pressure on our Emergency Departments. They have been operating for 13 years and in that time have become a critical part of our health system.
- Their introduction has been associated with a statistically significant decline in the proportion of primary care type presentations to ACT Emergency Departments; that is 1.9% per year between 2023-14 and 2020-21.
- The Commonwealth's UCC model enables flexibility in approach to ensure the funding is used to best support the needs of local communities. We have worked closely with the Commonwealth on this innovative model and will be closely monitoring the impacts on our Emergency Departments and the care being delivered.
- The Commonwealth has also committed to evaluating the UCC program at the national level.

# Will the UCC Walk-in Centres be able to provide the same level care as the GP-led UCCs operating in other jurisdictions?

- Our Walk-in Centres are nurse-led and therefore they have a different scope of practice to GPs.

# Why is Weston Creek getting more services than the other Walk-in Centres across the ACT? How have these decisions been made?

- Services at all Walk-in Centres will be boosted through this funding, with more nurses and more equipment at all Centres.
- The Weston Creek Walk-in Centre is co-located with the Weston Creek Medical Imaging Service. The new medical imaging staff will increase capacity of this existing service to provide after-hours imaging, which all Canberrans can access.
- The advanced scope physiotherapist will based at Weston Creek Walk-in Centre to complement the medical imaging service, which will see Canberrans able to receive assessment, medical imaging, and treatment for a minor injury all in the same location, without the need to go to the hospital.
- The physiotherapist will also provide virtual assessments and support for nursing staff in other Walk-in Centres if appropriate to the condition.

Dr Dorrington is on leave currently and I am working in clinical practice tomorrow, so a very quick reply in terms of cost of seeing a GP. I have not done a comprehensive analysis but this is based on the costs I found for level B consults at various clinics across Canberra.

In terms of the questions posed below and the reference to the WICs, I will present costs incurred for a 'level B' (standard) consult, in which most WIC presentations could be addressed.

Most private GP clinics charge between \$75 (concession card fee) and \$110 for a level B consult. Patients are then entitled to a federal government rebate of \$40.10. Out of pocket cost therefore varies between \$35-\$60.

Cost to Federal Government: \$40.10

Cost to consumer \$35-\$60.

When patients are bulk billed, the doctor discounts their fee and accepts the patient's Medicare rebate as full payment for the consult. For some groups (Commonwealth concession card holders, Children <16) the Federal Government also provides a bulk-billing incentive of \$20.65.

Cost to Federal Government: \$40.10 - \$60.75.

Cost to consumer: Nil

There is no ACT Government funding of GP visits.

All health services have different, but equally important roles to play in the provision of health care within the ACT community. Some of the main health care options in the ACT include:

- General Practitioners (GPs): they are the first point of contact for all health concerns unless
  it's an emergency. They provide immediate short-term care and long-term care for complex
  needs. They can coordinate care for multiple health needs.
- Walk-in Centres: provide free health care for non-life-threatening injuries and illnesses to anyone over one year of age. The centres are open from 7.30am to 10pm, every day of the year. Appointments are not needed.
- Emergency Departments: for immediate life-threatening conditions, such as severe difficulty breathing, stroke, uncontrollable bleeding etc.
- Pharmacies: Community pharmacists do more than just give medication. They provide advice and other services like blood glucose testing and vaccinations.
- Canberra Health Services community care: Canberra has a range of free public health services, everything from specialised clinics and services to preventive care and screenings.

Our Walk-in Centres are led by a team of highly skilled advanced practice nurses and nurse practitioners who provide care to patients with non-life-threatening injury or illness.

There were over 115,000 presentations at five Walk-in Centres last year and around 6% of patients were redirected to an emergency department from a walk-in centre in 2022.

GPs are an incredibly important part of our primary health care network in the ACT. They play a central role in providing ongoing care to people and are often the first point of contact for patients within the health care system.

However, with some of the lowest rates of bulk billing and prevalence of full-time equivalent GPs, access and cost are challenges for Canberrans (2024 Report on Government Services).

### The impact of Walk-in Centres

ACT Emergency Departments have experienced significant growth in presentations in the past decade, averaging 3.4% growth per year between 2004-05 and 2020-21.

Walk-in Centres were introduced in the ACT in 2010 to help alleviate pressure on our Emergency Departments. They have been operating for 14 years and in that time have become a critical part of the health care options available to Canberrans. Over this period, their scope of practice has also increased responding to the needs of the community. For example, Walk-in Centres now treat anyone over the age of one and urinary tract infections for women.

Their introduction has been associated with a statistically significant decline in the proportion of primary care type presentations (that is, presentations that can be treated by a GP or Walk-in Centre) to ACT Emergency Departments; of 1.9% per year between 2013-14 and 2020-21.

Any financial data from reviews conducted in 2010 about our Walk-in Centres is outdated, and as presentations increase the per unit cost decreases. In addition, our consumer satisfaction with the service provided at our Walk-in Centres continues to grow.

Our Walk-in Centres are an important part of an overall system approach, and this new funding is increasing their capacity to enable better access for Canberrans to urgent care when they need it (in particular with extended hours), which is a primary aim of the Medicare UCC program. Overtime, it will also enable a wider range of conditions to be treated with new equipment.

Our Walk-in Centres have well established referral processes in place to ensure patients requiring more complex care are referred to the appropriate public provider. They also encourage patients to follow-up with their GP and can send an event summary to the GP.

We continue to work closely with community-based health services, including general practitioners, to ensure we are delivering an integrated health system where Canberrans can access the right care in the right place and at the right time

#### Further context:

CAS has informed me that we do not have the current cost per walk-in centre patient.

In speaking to the journalist over the phone, she informed me that she has spoken to some GPs as part of the story who mentioned the following:

- · They believe walk-in centres haven't taken much pressure off emergency departments
- They are concerned that GPs aren't part of the UCC network in the ACT when they are in other jurisdictions.

Regarding the mention of 'inbound and outbound patients', the journalist didn't entirely understand how and when patients are redirected to an emergency department. So, she is satisfied with just the redirection percentage.

### Statement can be attributed to an ACT Government spokesperson:

All health services have different, but equally important roles to play in <u>T</u>the provision of health care within the ACT community relies on a network of service providers performing different and essential roles. Some of the main health care options in the ACT include:

- General Practitioners (GPs): they are the first point of contact for all health concerns unless
  it's an emergency. They provide immediate short-term care and long-term care for complex
  needs. They can coordinate care for multiple health needs.
- Walk-in Centres: provide free health care for non-life-threatening injuries and illnesses to anyone over one year of age. The centres are open from 7.30am to 10pm, every day of the year. Appointments are not needed.
- Emergency Departments: for immediate life-threatening conditions, such as severe difficulty breathing, stroke, and uncontrollable bleeding.
- Pharmacies: Community pharmacists do more than just give medication. They provide advice and other services like blood glucose testing and vaccinations.
- Canberra Health Services community care: Canberra has a range of free public health services, everything from specialised clinics and services to preventive care and screenings.

Our Walk-in Centres are led by a team of highly skilled advanced practice nurses and nurse practitioners who provide care to patients with non-life-threatening injury or illness.

They make a huge difference to the day to day lives of Canberrans, providing anyone over one year of age with a health assessment and treatment for a wide range of health needs. Further information can be found on the <a href="CHS website">CHS website</a>.

Around 6% of patients were redirected to an emergency department from a walk-in centre in 2022.

GPs are an incredibly important part of our primary health care network in the ACT. They play a central role in providing ongoing care to people and are often the first point of contact for patients within the health care system.

However, with some of the lowest rates of bulk billing and prevalence of full-time equivalent GPs, access and cost are challenges for Canberrans (2024 Report on Government Services).

#### The impact of Walk-in Centres

ACT Emergency Departments have experienced significant growth in presentations in the past decade, averaging 3.4% growth per year between 2004-05 and 2020-21.

Walk-in Centres were introduced in the ACT in 2010 to help alleviate pressure on our Emergency Departments. They have been operating for 14 years and in that time have become a critical part of the health care options available to Canberrans. Over this period, their scope of practice has also increased responding to the needs of the community.

Their introduction has been associated with a statistically significant decline in the proportion of primary care type presentations (that is, presentations that can be treated by a GP or Walk-in Centre) to ACT Emergency Departments; of 1.9% per year between 2013-14 and 2020-21.

Any financial data from reviews conducted in 2010 about our Walk-in Centres is outdated, and as presentations increase the per unit cost decreases. In addition, our consumer satisfaction with the service provided at our Walk-in Centres continues to grow.

#### Urgent Care Clinic model in the ACT

Much thought was put into how the Urgent Care Clinic (UCC) model would be implemented given the unique context that we have in the ACT. Key contextual factors considered included our low ratio of GPs per 100,000 people, which is one of the lowest in the country.

The Commonwealth's UCC model enables flexibility in approach to ensure the funding is used to best support the needs of local communities. The ACT Government worked closely with the Commonwealth on this innovative model and will be closely monitoring the impacts on our Emergency Departments and the care being delivered.

Our Walk-in Centres are an important part of an overall system approach, and this new funding is increasing their capacity to enable better access for Canberrans to urgent care when they need it (in particular-with after hours, when other services are unavailable), which is a primary aim of the Medicare UCC program. Overtime, it will also enable a wider range of conditions to be treated with new equipment.

Our Walk-in Centres have well established referral processes in place to ensure patients requiring more complex care are referred to the appropriate public provider. They also encourage patients to follow-up with their GP and can send an event summary to the GP.

We continue to work closely with community-based health services, including general practitioners, to ensure we are delivering an integrated health system where Canberrans can access the right care in the right place and at the right time.

# ACT Urgent Care Clinics – Alternate model

The purpose of this document is to outline an alternate model for ACT Urgent Care Clinics (UCCs), in response to a request from the Department of Health and Aged Care on 31 May 2023.

The Department has requested the ACT consider an alternate model that comprises:

- Extended coverage of Nurse Practitioners across all Walk in Centres (WICs) across all hours of operation, in place of a GP; and
- Access to medical imaging services from each Centre, including consideration of potential outsourcing arrangement(s) with local provider(s).

Total UCC funding for the ACT will remain the same. Options for advanced scope physiotherapists will still be considered.

# ACT Walk in Centre – current services

Walk-in Centres provide free health care for non life-threatening injuries and illnesses to anyone who is over one year of age. All five ACT WICs are open 7 days a week, including Christmas Day and New Year's Day between 7.30am and 10pm. All centres operate on a noappointment, walk in model.

The Centres are staffed by Advance Practice Nurses and Nurse Practitioners and provide a range of urgent care services including assessment and treatment of:

- Asthma
- Bites, stings, ticks
- Cellulitis
- Ear Nose and Throat infections (sinusitis, tonsillitis, middle and outer ear infections)
- Ear wax removal
- Emergency contraception
- Gastroenteritis
- Limb injuries including uncomplicated limb, hand and finger fractures.
- Minor head injury
- Migraine
- Mental health first aid
- Primary dysmenorrhea
- Skin conditions infections, rashes dermatitis, school sores, paronychia
- Sick certificates
- STI screening for chlamydia.
- Tetanus boosters if needed following injury.
- Uncomplicated urinary tract infections
- Viral respiratory illness (cough, cold, sore throat, influenza, Covid, croup)
- Wound care
  - wound closure (suturing and gluing)



- o cuts, abrasions, bruises, burns, lacerations
- o digital nerve block to assist with management of finger injury.
- excision and drainage of simple skin infections eg. boils.

ACT WICs are located in Weston Creek, Gungahlin, Belconnen, Inner North (Dickson) and Tuggeranong. All centres offer the services listed above.

From 31 May 2023, services at Weston Creek WIC will be expanded to include diagnostic medical imaging including ultrasound, Computed Tomography (CT) and X-Ray to improve community access to outpatient imaging services and help reduce pressure and wait times in EDs. Hours of operation of medical imaging at Weston Creek WIC will be 9:00 to 17:00 business days, as delivered through ACT Government funding.

## The ACT Urgent Care Clinic model

The proposed ACT UCC investment leverages the success of the ACT WIC model to expand services across all five ACT WICs to relieve pressure on ACT EDs.

#### *Inclusions*

The investment will support:

- Additional nursing FTE
  - 3.5 FTE RN 4.2 to enable Nurse Practitioner coverage across all WICs across all hours of operation.
  - 2.9 FTE RN 3.1 to enhance Advance Practice Nurse coverage across all WIC sites and enhance training pathways across the Centres.
- Additional allied health for Weston Creek WIC
  - Radiographer (0.8FTE) and sonographer (0.8 FTE) services to enable afterhours medical imaging
  - Advanced scope physiotherapist for onsite specialist musculoskeletal assessment, diagnosis, management<sup>1</sup> and consultative 'one stop' services (1.8 FTE).
- Additional equipment to facilitate point of care testing, diagnosis and treatment interventions:
  - Slit Lamps (x2 one each for Weston and Belconnen) to facilitate better eye examinations and removal of foreign bodies in eyes;
  - Hand held ultrasounds (x5 one for each centre) to assist in examination of deep lacerations, abscesses and foreign bodies;
  - Tanometer (x2 one each for Weston and Belconnen) for eye examinations;
  - Handheld vascular doppler (x1 for Weston) for investigating blood flow/thrombosis.
- FTE (0.7) to support new data reporting to the Commonwealth for UCCs.

Virtual services can be provided for all services delivered by advanced practice physiotherapists operating from Weston Creek WIC; including assessment, treatment and/or virtual support for onsite nursing staff as appropriate to the condition.

Options to engage private medical imaging providers to provide services across the remaining four Centres (other than Weston Creek) will be considered using MBS revenue generated by Nurse Practitioners funded through the UCC investment (estimated \$242,000 per annum).

## Expanded scope of WIC services

The advanced scope physiotherapist at Weston Creek WIC, coupled with onsite medical imaging services, will enable onsite diagnosis and treatment of a range of musculoskeletal conditions not currently offered at WICs and that are outside the scope of nursing staff at WICs.

The extension of Nurse Practitioner staff across all Centres across all hours of operation will increase service provision with work towards:

- Enabling assessment and treatment of patients under 1 year of age at specific centres over time
- Treatment for UTI male and female at all centres
- Removal of foreign bodies in eyes with a slit lamp at 2 centres
- Full STI screening and commencement of treatment
- Treatment of minor illness and injury in pregnancy
- Increased diagnostic ordering scope will increase the conditions able to be seen by NP at all WiCs eg- clavicle fracture, shoulder injury.

The investment in new equipment and an advanced scope physiotherapist will also expand the scope of services offered at ACT WICs to include:

- Removal of foreign bodies<sup>2</sup>
- Thumb injuries
- Hip pain
- Musculoskeletal spinal pain
- Simple joint dislocations
- Simple fracture reductions
- Complex limb injuries/ presentations (that would currently be excluded), such as:
  - persistent and atraumatic joint pain
  - some suspected complex fractures
  - closed tendon ruptures (hand, Achilles, biceps)
  - Knee injuries where the patient can't bend >90 degrees or reports locking
  - Shoulder pain with deformity, suspected fractures, loss of range, traumatic history
- Expedited fracture and dislocation management:

- CHS credentialled advanced practice physiotherapists can independently review X-rays and develop a treatment plan (nurses in WiCs wait for the formal report before a treatment decision is made – advanced practice physiotherapists could support the review of X-rays for nursing colleagues to expedite services).
- Once radiographically diagnosed, management of common fractures can be directed by advanced practice physiotherapists with direct referral to CHS outpatient orthopaedic and plastics clinics<sup>3</sup>. This avoids the need for ED presentation.

Revenue will be invested in expansion of medical imaging services across remaining four WICs, with consideration to outsourcing models.

## Expected impact of the ACT UCCs

The ACT UCC investment is expected to have a direct impact on pressure across ACT EDs by expanding the service offering across ACT WICs. This includes to both reduce the rate of redirections from ACT WICs and initial presentations to EDs.

Since Jan 2023, five centres have had 45,355 presentations; 90,000 presentations are predicted for the 2023 calendar year.

With increased NPs and physiotherapy for musculoskeletal injuries, this will result in an estimated 15 additional patients per clinic, per day, being seen. At Weston Creek the increase will be greater with the additional of the advanced scope physiotherapist. These numbers are estimates based upon approximated activity of clinicians.

## ED presentations

ACT EDs have experienced statistically significant growth in presentations over the past decade, averaging 3.4% growth per year between 2004/5 to 2020/21 (95% confidence intervals: 3.1% to 3.7%)<sup>4</sup>. This trend is projected to continue without active intervention.




Figure 1. Observed and predicted numbers of ED presentations to ACT hospitals.

WICs were introduced in 2010 to alleviate the pressure on EDs because of extreme GP shortages. Their introduction has been associated with a statistically significant decline in the proportion of primary care type presentations to ACT EDs; that is 1.9% per year between 2013/14 to 2020/21.

The decline in primary care type ED presentations is consistent with increasing provision of WIC services.

However, the number of primary care type presentations to EDs remains relatively high, which presents an opportunity to target through the UCC investment.




Figure 3. Primary care type Emergency Department presentations.

The expansion of Nurse Practitioner coverage, medical imaging and introduction of an advanced practice physiotherapist at Weston Creek WIC is expected to further reduce primary care type presentations. This includes across all leading diagnostic causes of primary care type ED presentations to ACT EDs across gender and age groups (refer to Appendix A).

#### WIC redirections

For the period 1 July 2020 to 20 June 2022, 6.8% WIC presentations were redirected to an ED. The ACT UCC investment therefore presents an opportunity to reduce this redirections rate through the increase in nurse practitioners and their extended scope of practice, expansion of services offered by medical imaging and advanced scope of practice physiotherapists.

Of the leading causes of WIC redirections to EDs (see Figure 4), it is expected ACT UCC services will have the greatest impact on musculoskeletal, abdominal pain, minor head injury, infection, eye and respiratory type referrals to the ED.

It is not expected the ACT model will reduce redirections for chest pain, complex lacerations or complex fractures as these require hospital-based assessment and treatment.



## **Original questions:**

I'm doing a story about nurse-led walk-in centres in the ACT and seek responses to the following questions:

- 1. What is the current or last known average cost per patient/service in ACT walk-in centres? In this report, it was \$196 per service in 2010.
- 2. When was the last time ACT walk-in centres were reviewed for their cost and reducing the number of patients presenting at EDs?
- 3. How many inbound and outbound patients seen at walk-in centres were referred to EDs?

### **Further context:**

In speaking to the journalist over the phone, she informed me that she has spoken to some GPs as part of the story who mentioned the following:

- They believe walk-in centres haven't taken much pressure off emergency departments
- They are concerned that GPs aren't part of the UCC network in the ACT when they are in other jurisdictions.

Regarding the mention of 'inbound and outbound patients', the journalist didn't entirely understand how and when walk-in centre patients are redirected to an emergency department. So, she is satisfied with just the redirection percentage.

## Statement can be attributed to an ACT Government spokesperson:

Our Walk-in Centres are led by a team of highly skilled advanced practice nurses and nurse practitioners who provide care to patients with non-life-threatening injury or illness.

There were over 115,000 presentations at the five ACT Walk-in Centres in 2023.

In the 2022/23 ACT Budget, there was \$12,618,233 in funding for the five Walk-in Centres.

For the period 1 July 2020 to 20 June 2022, 6.8% Walk-in Centre presentations were redirected to an emergency department.

## The impact of Walk-in Centres

ACT Emergency Departments have experienced significant growth in presentations in the past decade, averaging 3.4% growth per year between 2004-05 and 2020-21.

Walk-in Centres were introduced in the ACT in 2010 to help alleviate pressure on our Emergency Departments. They have been operating for 14 years and in that time have become a critical part of the health care options available to Canberrans. Over this period, their scope of practice has also increased responding to the needs of the community.

Their introduction has been associated with a statistically significant decline in the proportion of primary care type presentations (that is, presentations that can be treated by a GP or Walk-in Centre) to ACT Emergency Departments; averaging 1.9% per year between 2013-14 and 2020-21.

## **Urgent Care Clinic model in the ACT**

Much thought was put into how the Urgent Care Clinic (UCC) model would be implemented given the unique context that we have in the ACT. Key contextual factors considered included our low ratio of GPs per 100,000 people, which is one of the lowest in the country.

The Commonwealth's UCC model enables flexibility in approach to ensure the funding is used to best support the needs of local communities. The ACT Government worked closely with the Commonwealth on this innovative model and will be closely monitoring the impacts on our Emergency Departments and the care being delivered.

Our Walk-in Centres are an important part of an overall system approach, and this new funding is increasing their capacity to enable better access for Canberrans to urgent care when they need it (in particular after hours, when other services are unavailable), which is a primary aim of the Medicare UCC program. Overtime, it will also enable a wider range of conditions to be treated with new equipment.

Our Walk-in Centres have well established referral processes in place to ensure patients requiring more complex care are referred to the appropriate health provider. They also encourage patients to follow-up with their GP and can send an event summary to the GP.

We continue to work closely with community-based health services, including general practitioners, to ensure we are delivering an integrated health system where Canberrans can access the right care in the right place and at the right time.

## Statement can be attributed to an ACT Government spokesperson:

The ACT's nation-leading nurse-led Walk-in Centre network has continued to expand since the 2010 report to look at the viability of the Walk-in Centre model.

The cost of \$196 per service in 2010 would no longer be relevant due to the expansion of the network, growth in presentations and increase in staffing profile. The 2010 evaluation highlighted the reduction in costs that would come with an increase in presentations and that Walk-in Centres cost significantly less than an average emergency department presentation.

Canberra Health Services does not record the cost of each presentation to a Walk-in Centre.

In the 2022-23, the ACT Government allocated \$12,618,233 in funding for the five Walk-in Centres. There were over 115,000 presentations across the network in 2023, this is more than the total amount of emergency department presentations to North Canberra Hospital.

Averaging expenditure across presentations, this would be less than \$110 per presentation, which is approximately the same cost as a standard GP consultation at many ACT practices. Consultations at a WIC are often longer than a standard 15-minute GP appointment due to the need to assess and treat injuries and the fact that patients raise issues beyond the minor injury or illness with which they present. Walk-in Centres also provide services for extended hours 365 days a year.

It would not be accurate to compare Walk-in Centre costs with the Medicare rebate for a standard GP consultation, as a similar visit to a GP may see multiple services billed to Medicare or otherwise funded by government (for example, if a patient sees a practice nurse to dress a wound or receive an immunisation, this would be billed to Medicare in addition to the GP consultation or funded through the Workforce Incentive Program).

In recent years, the percentage of Walk-in Centre presentations being redirected to the emergency department has been between 5-7%. For example, data from July to September 2022 showed 5.9% of presentations were redirected to an emergency department.

The introduction of Walk-in Centres has been associated with a statistically significant decline in the proportion of primary care type presentations (that is, presentations that can be treated by a GP or Walk-in Centre) to ACT Emergency Departments, averaging 1.9% per year between 2013-14 and 2020-21.

### The impact of Walk-in Centres

Canberra's network of nurse-led Walk-in Centres plays a valuable role in the overall ACT public health system, providing people with access to free public healthcare for non-life-threatening illnesses and injuries.

The ACT Government recognises the valuable role GPs play in supporting the health and wellbeing of our community. The Walk-in Centres are not designed as an alternative to GPs. They provide an option for people to seek treatment for one-off injuries and illnesses.

With more than 115,000 presentations last year, we know the Walk-in Centres are a valued and needed healthcare option for the ACT.

## Urgent Care Clinic model in the ACT

The proposal to have GPs included in the Urgent Care Centre network was considered during consultation. Ultimately, the Commonwealth and ACT Government agreed to maintain the fully nurse-led model of care for the network.

This investment has delivered funding for an increase in the number of nurses and allied health professionals – three new nurse practitioners and three new advanced practice nurses; an advanced scope physiotherapist for the Weston Creek Walk-in Centre to treat patients with musculoskeletal injuries (and to provide virtual assessments and support for the nursing staff at other walk-in centres); and a radiographer and sonographer at the Weston Creek medical imaging service, to expand the service to provide after-hours imaging.

Under this initiative, funding will also provide more equipment for the nurse-led walk-in centres to treat a wider range of conditions. This includes slit lamps and tonometers for eye examinations and removal of foreign objects in the eyes; handheld ultrasound machines for the examination of lacerations and other wound types; and vascular dopplers for investigating blood flow. This is all about enabling our highly skilled advanced practice nurses and nurse practitioners to work to an even wider scope of practice.

The scope of services is planned to further expand to include treatment for: shoulder injuries; male urinary tract infections; injuries for people who are pregnant; and screening for sexually transmitted infections.

Our Walk-in Centres have well established referral processes in place to ensure patients requiring more complex care are referred to an appropriate health provider. Patients are also encouraged to follow-up with their GP and WICs can send an event summary to the GP with a patient's consent.

The ACT Government will continue to work closely with community-based health services, including GPs, to ensure we are delivering an integrated health system where Canberrans can access the right care in the right place and at the right time.

In developing this model, the Minister and Health Directorate reflected on a visit to one of South Australia's GP-led Priority Care Centres in 2022, where the challenge of GP recruitment was a prominent topic, particularly to cover weekends and extended hours. It was apparent from this visit that advanced practice nurses and nurse practitioners would be able to provide almost the full scope of services offered by these Centres, supported by additional investment in equipment and access to imaging services.

In addition, a GP-led model would not reduce fragmentation of services, as it would still be a separate service from the person's usual GP providing one-off care for an acute presentation.
