

### DECISION ON YOUR ACCESS APPLICATION

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by Canberra Health Services (CHS) on **Thursday 29 June 2023**.

This application requested access to:

'Correspondence between the Ministers office, MAGS and the head of the line area who organises monthly packaging with Question on Notice 1253.

- *I am particularly interested in emails that explain why monthly benchmarking packages between August and November 2022 and,*
- Why monthly benchmarking packages can not be provide including discussion about data validity after DHR implementation.'

I am an Information Officer appointed by the Chief Executive Officer of Canberra Health Services (CHS) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. CHS was required to provide a decision on your access application by **Thursday 10 August 2023**.

I have identified seven documents holding the information within scope of your access application. These are outlined in the schedule of documents included at <u>Attachment A</u> to this decision letter.

### **Decisions on access**

I have decided to:

- grant full access to six documents; and
- grant partial access to one document.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request; and
- The Human Rights Act 2004.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

### Full Access

I have decided to grant full access to documents at references 1-4 and 6-7.

#### Partial Access

I have decided to grant partial access to the document at reference 5 as it contains information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in section 17 of the FOI Act.

#### Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the disclosure of the documents:

- Schedule 2, 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability; and
- Schedule 2, 2.1(a)(ii) contribute to positive and informed debate on important issues or matters of public interest.

#### Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

• Schedule 2, 2.2 (a)(ii) prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2004*.

The documents have redactions made to the mobile number of an ACT Government employee. These have not been disclosed as this could reasonably be expected to prejudice the protection of the individual's right to privacy.

On balance, the factor favouring disclosure were outweighed by the factors favouring non-disclosure as I have determined that the information would be expected to prejudice individuals' right to privacy. Therefore, I determined the information identified is contrary to the public interest and I have decided not to disclose this information.

#### Charges

Processing charges are not applicable to this request.

#### **Disclosure Log**

Under section 28 of the FOI Act, CHS maintains an online record of access applications called a disclosure log. The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. Your personal contact details will not be published.

#### **Ombudsman review**

My decision on your access request is a reviewable decision as identified in Schedule 3 of the FOI Act. 

The ACT Health Directorate and Canberra Health Services have agreed that further refinement and quality assurance is required prior to releasing this data. With the wealth of additional data provided by the new DHR, it is imperative that additional quality assurance and validation on this data be completed to ensure ACT public hospital data provides accurate and trustworthy information. As a result, there is no benchmarking data available at this time.
