DECISION ON YOUR ACCESS APPLICATION

Our reference: ACTHDFOI22-23.57

I refer to your application under section 30 of the *Freedom of Information Act 2016* (FOI Act), received by ACT Health Directorate (ACTHD) received by the ACT Health Directorate (ACTHD) on **Friday 23 June 2023**.

This application requested access to:

- 1) Any records or documents produced or held by CHS between 20th December 2022 and 23rd June 2023 in relation to both Calvary Public Hospital Bruce and the Government Procurement Act 2001 (ACT), including but not limited to:
 - a. Correspondence between, or documents produced or held by officers of CHS in relation to effects of the Government Procurement Act 2001 (ACT) on the proposed acquisition of Calvary Public Hospital Bruce;
 - b. Correspondence between officers of CHS and Calvary Public Hospital Bruce or the Little Company of Mary Health Care Limited in relation to effects of the Government Procurement Act 2001 (ACT) on the proposed acquisition of Calvary Public Hospital Bruce; and
 - c. Correspondence including email, SMS and electronic messenger correspondence involving one or more of Rachel Stephen-Smith, David Peffer, Elizabeth Loper and Cathie O'Neill in relation to effects of the Government Procurement Act 2001 (ACT) on the proposed acquisition of Calvary Public Hospital Bruce.
- 2) Any records or documents produced or held by CHS between 20th December 2022 and 23rd June 2023 in relation to both Calvary Public Hospital Bruce and the Secure Local Jobs Code 2020 including but not limited to:
 - a. Correspondence between, or documents produced or held by officers of CHS in relation to effects of the Secure Local Jobs Code 2020 on the proposed acquisition of Calvary Public Hospital Bruce;
 - b. Correspondence between officers of CHS and Calvary Public Hospital Bruce or the Little Company of Mary Health Care Limited in relation to effects of the Secure Local Jobs Code 2020 on the proposed acquisition of Calvary Public Hospital Bruce; and
 - c. Correspondence including email, SMS and electronic messenger correspondence involving one or more of Rachel Stephen-Smith, David Peffer, Elizabeth Loper and Cathie O'Neill in relation to effects of the Secure Local Jobs Code 2020 on the proposed acquisition of Calvary Public Hospital Bruce.

I am an Information Officer appointed by the Director-General of ACT Health Directorate (ACTHD) under section 18 of the FOI Act to deal with access applications made under Part 5 of the Act. ACTHD was required to provide a decision on your access application by **Friday 04 August 2023**.

I have identified **15 documents** holding the information within scope of your access application. These are outlined in the schedule of documents included at <u>Attachment A</u> to this decision letter.

Decisions on access

I have decided to:

- grant full access to one documents; and
- grant partial access to 14 documents.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as <u>Attachment B</u> to this letter.

In reaching my access decision, I have taken the following into account:

- The FOI Act;
- The contents of the documents that fall within the scope of your request;
- The views of relevant third parties; and
- The Human Rights Act 2004.

Full Access

I have decided to grant full access to the information in scope of your application within one document at reference 10.

Partial Access

I have decided to grant partial access to the information in scope of your application within 14 documents.

Documents at references 1, 3, 6-7 and 11-12 are partially comprised of information classified as information subject to legal professional privilege information, and under Schedule 1.2, it is taken to be contrary to the public interest to release. Schedule 1.2 information that would be privileged from production or admission into evidence in a legal proceeding on the ground of legal professional privilege. These documents are also partially comprised of information classified as Cabinet information, and under Schedule 1.6 (1) Cabinet Information, it is taken to be contrary to the public interest to release. Schedule 1.6 would reveal any deliberation of Cabinet (other than through the official publication of a Cabinet decision).

Document at reference 2 is partially comprised of personal information such as email addresses and phone numbers of non-government employees and mobile numbers of ACT-Government employees in accordance with Schedule 2, 2.2 (a)(ii) prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2004*. This document contains partial information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in section 17 of the Act.

Documents at references 4 and 8-9 are partially comprised of information classified as legal professional privilege information under Schedules 1.2.

Documents at references 13 and 15 are partially comprised of information classified as legal professional privilege information under Schedules 1.2 and personal information under Schedule 2, 2.2 (a)(ii) privacy. These documents contain partial information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in section 17 of the Act.

Document at reference 14 is partially comprised of information classified as legal professional privilege information and cabinet information under Schedules 1.2 and 1.6. This document also contains information that would be contrary to the public interest in accordance with Schedule 2, 2.2 (a)(ii) privacy. This document contains partial information that I consider, on balance, to be contrary to the public interest to disclose under the test set out in section 17 of the Act.

Public Interest Factors Favouring Disclosure

The following factors were considered relevant in favour of the disclosure of the documents:

- Schedule 2, 2.1 (a)(i) promote open discussion of public affairs and enhance the government's accountability;
- Schedule 2, 2.1 (a)(ii) contribute to positive and informed debate on important issues or matters of public interest;
- Schedule 2, 2.1 (a)(iv) ensure effective oversight of expenditure of public funds; and
- Schedule 2, 2.1 (a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision.

Public Interest Factors Favouring Non-Disclosure

The following factors were considered relevant in favour of the non-disclosure of the documents:

• Schedule 2, 2.2 (a)(ii) prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2004*.

On balance, the factors favouring disclosure did not outweigh the factors favouring non-disclosure as the release of the redacted information would or could reasonably be expected to prejudice the privacy of individuals. Therefore, I determined the information identified is contrary to the public interest and I have decided not to disclose this information.

Charges

Processing charges are not applicable to this request.

Disclosure Log

Under section 28 of the FOI Act, ACTHD maintains an online record of access applications called a disclosure log. The scope of your access application, my decision and documents released to you will be published in the disclosure log not less than three days but not more than 10 days after the date of this decision. Your personal contact details will not be published.

Ombudsman review

Operational Transition Procurement Requirements

Key to the operational transition of services from Calvary to Canberra Health Services is the uninterrupted provision of goods and services.

Currently the Health Infrastructure Enabling Bill and Regulation allow for the disapplication of the Government Procurement Act for the novation of contracts.

We discussed that novation may be too narrow to achieve the Territory's objectives which may require a range of different contractual solutions, including:

- A new contract to the same supplier for the same goods and services; or
- An extension or resizing of existing CHS contracts to cover any gaps or requirements; or
- Other options required to ensure continuity of service provision.

We agreed that while it would be appropriate to disapply the Government Procurement Act to assist in meeting this operational need, a fit for purpose process should be developed to protect the Territory's interest in relation to value for money, secure local jobs, ethical suppliers and other pertinent procurement principles.

PCO advise that to support this we can prescribe this in regulation and the process itself can become an instrument for transparency sake.

Again, we will work with Sanaz Mirzabegian to discuss and develop an appropriate approach to ensuring ongoing good governance in procurement and supply as it relates to the Northside Hospital Transition.





Dear Cathie and Liz

For your information, comment and direction please see attached the proposed assembly amendments to be moved by the Minister for Health on the Bill.

To assist your commentary on the amendments the Team has pulled together the table, attached. It goes through the amendments, outlines our position, those amendments we are seeking a decision/advice/direction on and also provides an explanation for the amendment. I am also attaching the relevant version of the Bill for ease of reference.

The amendments requiring most significant attention are:

Out of Scope

- 3 – broader disapplication of Government Procurement Act. Please note further commentary on this below. Out of Scope

Further commentary on the procurement act issue:

As has been previously discussed with the ACTHD, the *Government Procurement Act 2001* is disapplied by s 6(1)(b) to "anything done under this act". Any activity undertaken under the Act will therefore not be something to which the *Government Procurement Act 2001* applies. These include the assignment or novation of contract (and potentially renegotiation of the same, if provided for by regulation - see s14(2)(c)(ii)) pursuant to the process set out in the Health Infrastructure Enabling Act, once passed (the **Act**). Once nominated contracts have been assigned or novated consistent with the Act (and potentially been the subject of renegotiation) future dealings with those contracts may be the subject of the *Government Procurement Act 2001*. In addition, any new contracts referable to the operation of the public hospital moving forward will be subject to the operation of the *Government Procurement Act 2001*.

- ACTHD has further considered the operational needs associated with contract requirements and discussed these with the Chair of the Procurement Board. Based on this we have requested the drafting of an additional amendment to disapply the procurement act so that in instances where the contracts can not be novated and a new contract is required, or a change of scope to an existing contract is required the GPA is not applied. This is to ensure this process can be undertaken quickly. ACTHD are further discussions on what the appropriate process to ensure the policy intent behind the GPA especially ethical suppliers and value for money can be met.
- I understand Lyndall has gone back to Peter on this and he is comfortable with it.

We need to agree the amendments (at least in principle) to progress to the Minister and CM to be agreed and lodged with the Clerk of the Assembly by Tuesday 12 noon to ensure debate can be done on the amended Bill.

Dear Cathie and Liz

For your information, comment and direction please see attached the proposed assembly amendments to be moved by the Minister for Health on the Bill.

To assist your commentary on the amendments the Team has pulled together the table, attached. It goes through the amendments, outlines our position, those amendments we are seeking a decision/advice/direction on and also provides an explanation for the amendment. I am also attaching the relevant version of the Bill for ease of reference.

The amendments requiring most significant attention are:

Out of Scope

- 3 – broader disapplication of Government Procurement Act. Please note further commentary on this below. Out of Scope

Further commentary on the procurement act issue:

- As has been previously discussed with the ACTHD, the *Government Procurement Act 2001* is disapplied by s 6(1)(b) to "anything done under this act". Any activity undertaken under the Act will therefore not be something to which the *Government Procurement Act 2001* applies. These include the assignment or novation of contract (and potentially renegotiation of the same, if provided for by regulation - see s14(2)(c)(ii)) pursuant to the process set out in the Health Infrastructure Enabling

Act, once passed (the **Act**). Once nominated contracts have been assigned or novated consistent with the Act (and potentially been the subject of renegotiation) future dealings with those contracts may be the subject of the *Government Procurement Act 2001*. In addition, any new contracts referable to the operation of the public hospital moving forward will be subject to the operation of the *Government Act 2001*.

- ACTHD has further considered the operational needs associated with contract requirements and discussed these with the Chair of the Procurement Board. Based on this we have requested the drafting of an additional amendment to disapply the procurement act so that in instances where the contracts can not be novated and a new contract is required, or a change of scope to an existing contract is required the GPA is not applied. This is to ensure this process can be undertaken quickly. ACTHD are further discussions on what the appropriate process to ensure the policy intent behind the GPA especially ethical suppliers and value for money can be met.
- I understand Lyndall has gone back to Peter on this and he is comfortable with it.

We need to agree the amendments (at least in principle) to progress to the Minister and CM to be agreed and lodged with the Clerk of the Assembly by Tuesday 12 noon to ensure debate can be done on the amended Bill.

The only other possible amendment we might make now is any clarification on the commencement of the regulation – Cathie can you please advise when you want this to commence?

I understand that Liz will also speak with Minister on these matters tomorrow.

But for your earliest advice to allow us to finalise one of the packages we are preparing for next week.






